



Can'd Aid Red Rocks Rendezvous

Official Sweepstakes Rules and Regulations

1. SWEEPSTAKES OVERVIEW

Can'd Aid, a nonprofit organization that has applied for recognition or has been granted status as a tax-exempt nonprofit organization under Section 501(c)(3) of the Internal Revenue Code, is conducting this Sweepstakes (the "Red Rocks Rendezvous") or (the "Sweepstakes") to raise funds for Can'd Aid. By obtaining a Sweepstakes Ticket, the entrant agrees to be bound by these Rules and Regulations. Can'd Aid's interpretation and application of the Rules and Regulations shall be final. These Rules and Regulations may be updated from time to time.

2. ELIGIBILITY

This Sweepstakes is open only to legal residents of the 48 Contiguous United States and the District of Columbia who are 18 years of age or older at the time of entry. Void in Alaska and Hawaii and wherever prohibited or restricted by law. Employees, officers and directors of the following entities and members of their immediate families (defined as parent, child, sibling, spouse) or same households (whether related or not) are NOT eligible to enter the Sweepstakes or win the prize: Can'd Aid, Tyler Childers and the Food Stamps, Relix Magazine, United Airlines, Origin Hotel, City and County of Denver, Red Rocks Amphitheatre and (as appropriate) each of their respective parent companies, subsidiaries, divisions, affiliates, prize suppliers, advertising and promotion agencies. Entries will not be accepted from inmates of a correctional facility. **By participating in the Sweepstakes, entrants agree to abide by and be bound by these Official Rules and the decisions of Can'd Aid which shall be final and binding in all respects.** All federal, state and local laws apply.

3. SWEEPSTAKES PERIOD:

The Sweepstakes begins on March 22, 2023 and ends at 11:59pm MST on September 4, 2023 ("Sweepstakes Period"). Mail-in entries must be received by 12:00am MST on August 15, 2023 to be eligible. Entries received outside this time will be ineligible and will be discarded. The Sweepstakes for the prize or prizes will be conducted by the Organization on September 8, 2023 at 5:00pm MST. The winner need not be present to win.

4. HOW TO ENTER:

Any eligible person may enter Can'd Aid Red Rocks Rendezvous Sweepstakes by obtaining an official Sweepstakes ticket ("Sweepstakes Ticket") from the Organization during the Sweepstakes Period. Sweepstakes Tickets may be obtained in the following manner: (1) ordering online by visiting and submitting an online ticket form with a GEM (gives every month) donation; (2) or by requesting a Sweepstakes Ticket free of charge to the Organization by using the method outlined below.

Sweepstakes Tickets obtained by a donation to the Can'd Aid will be issued based on the donor's GEM (gives every month) gift in the following increments: (1) \$5 for 20 tickets; (2) \$10 for 40 tickets; (3) \$20



for 100 tickets; (4) \$50 for 225 tickets; (5) \$100 for 500 tickets; (6) \$500 for 3,500 tickets. Only one person may be entered in the Sweepstakes per ticket or donation. Every month that the donor makes a GEM donation, will count as an additional entry. For instance if the donor gives four monthly \$5 donations, this will amount to 80 entries.

If the name of more than one person is submitted with a ticket donation, and that ticket is selected as a winning ticket, then the person named first will be deemed the holder of record of that ticket and declared the winner. Division of a prize or prizes by a group purchasing a ticket in common shall be the sole responsibility of the person named as the holder of record of that ticket, should that ticket be selected as the winner or winners. The Organization will not, and is not obligated to, honor an assignment of the prize or prizes to another person.

The Organization reserves the right to reject any entry form that is submitted with a donation that does not constitute "good funds," except as set forth below for requests for Sweepstakes Tickets without a donation. All defective or physically altered entry forms will be immediately disqualified by the Organization. Prior to the prize or prizes Sweepstakes, the Organization will make a reasonable effort to notify the individual and/or entity that submits such an entry form which has been rejected, by attempting to make contact through the information provided at the time of submitting the ticket request. The Organization assumes no responsibility for lost, late, or misdirected entries, or any other failure to receive orders or deliver receipts prior to the Sweepstakes deadlines.

If you wish to obtain a Sweepstakes Ticket without making a donation to the Organization, you must mail a hand-written request in your own handwriting entitled "Can'd Aid Red Rocks Rendezvous Official Sweepstakes Ticket Request" and include your complete name, street address, city, state, zip code, telephone number and email address, along with a self-addressed stamped #10 envelope to: Can'd Aid, 20 Bowen Street, Longmont, CO 80501. ATTN: Can'd Aid Red Rocks Rendezvous Sweepstakes Request. Your request must be legibly hand-written in your own handwriting in ink on paper or an index card no smaller than 3.5"x5" with the following statement: "I am 18 years of age or older, eligible to participate in this Sweepstakes and I agree to abide by the Sweepstakes rules." Requests that are mechanical reproductions, without sufficient return postage, or that do not have a verifiable and legible return address will not be accepted. There is a limit of one Sweepstakes Ticket per outer envelope. Mail-in requests must be postmarked by the postal processing center that serves the city listed on your home address. Vermont residents are not required to provide return postage.

The Organization will process the Can'd Aid Red Rocks Rendezvous Official Sweepstakes Ticket Requests in the same manner and order as a request accompanying a donation. After the request is processed, the Organization then enters the applicant in the Sweepstakes. You will not receive a confirmation of your entry.

5. ENTRY RESTRICTIONS:

Entries generated by script, macro, robotic, programmed or like means are prohibited and will be disqualified. Use of third-party entities (e.g., commercial Sweepstakes services) to enter Sweepstakes on a person's behalf voids entry, will result in disqualification from Sweepstakes and possible prohibition from participating in future promotions offered by Organization. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the Authorized Account Holder of the e-mail account associated with the Sweepstakes entry.



5. PRIZE(S):

One Grand Prize winner (1) is available to be awarded. The Grand Prize winner will receive two (2) Reserved Seating Concert Tickets for Tyler Childers and the Food Stamps at Red Rocks Amphitheatre in Morrison, Colorado on Wednesday, September 27, 2023 and Thursday, September 28, 2023. Two (2) Economy Cabin ER1181 United Airlines Travel Certificates with a retail value of \$5,200. These certificates are subject to all United Airlines terms – that can be updated at any time. These certificates may be used for two roundtrip tickets to Denver, Colorado – anywhere within the contiguous 48 states, three (3) nights lodging at Origin Hotel in Golden, CO on Wednesday September 27, 2023 through Friday September 29, 2023, two (2) volunteer slots at Can'd Aid's 10th anniversary Red Rock project. Date and location TBD. Two invites (grand prize winner and one guest) to Can'd Aid's instrument donation and music assembly with the Food Stamps, and one (1) private guided fly fishing day trip for two guests with Rocky Mountain Anglers, and miscellaneous Can'd Aid and Tyler Childers merchandise.

One Second Place winner will receive: two (2) Reserved Seating Concert Tickets for Tyler Childers and the Food Stamps at Fiddler's Green Amphitheatre in Greenwood Village, CO on Saturday September 30, 2023. Two (2) volunteer slots at Can'd Aid's 10th anniversary Red Rock project. Date and location TBD. An assortment of Can'd Aid and Tyler Childers merchandise.

One Third Place winner will receive two (2) Reserved Seating Concert Tickets for Tyler Childers and the Food Stamps at Fiddler's Green Amphitheatre in Greenwood Village, CO on Saturday September 30, 2023. Two (2) volunteer slots at Can'd Aid's 10th anniversary Red Rock project. Date and location TBD. An assortment of Can'd Aid and Tyler Childers merchandise.

Winner's guest must be 18 years of age or older and a legal resident of the United States or District of Columbia and must sign and return a Guest's Eligibility, Liability and Publicity release (where lawful) prior to attending the Concert. All expenses not specified in these Official Rules (including but not limited to transportation to and from Red Rocks Amphitheatre, parking and associated food and beverage costs) are the sole responsibility of the winner.

IF POTENTIAL WINNER(S) CANNOT ATTEND THE CONCERT ON THE DATES SPECIFIED ABOVE OR IF POTENTIAL WINNER DOES NOT WISH TO ATTEND THE CONCERT, THE PRIZE WILL BE FORFEITED WITHOUT COMPENSATION AND AN ALTERNATE MAY BE SELECTED AT ORGANIZATION'S SOLE DISCRETION (TIME PERMITTING). No other prize will be awarded. By claiming tickets you agree to the Terms and Conditions and to abide by the health and safety measures in effect at the time of the Concert, which may include, but not be limited to, wearing masks, providing proof of vaccination status and/or providing proof of negative COVID-19 status. Should the Concert/Event be cancelled, you will be notified as soon as reasonably possible. Approximate Retail Value of Prize is up to up to \$2,500.00 depending on number of tickets awarded. Should actual value of prize be less than the stated Approximate Retail Value for any reason, winner will not receive the difference in cash or otherwise. No other prize will be awarded.

*If winner chooses to attend the Concert without a guest (or guest does not timely return signed Guest's Eligibility, Liability and Publicity Release), winner will receive the prize in increments appropriate for winner themselves and no substitute prize or compensation will be awarded in conjunction therewith; that is, winner will only receive one (1) ticket to the Concert.



Winner and winner's guest must abide by all venue policies. Can' Aid, Tyler Childers, Relix Magazine, United Airlines, Origin Hotel, City and County of Denver and/or Red Rocks Amphitheatre reserve the right to not award the prize to, or to revoke prize from winner or winner's guest who they or venue personnel deem may, in their sole discretion, be intoxicated, be a safety risk, have violated any venue policy or law, and/or may bring Organization, associated sponsors and/or Red Rocks Amphitheatre into disrepute, and under such circumstances, Organization, Sponsors and/or Red Rocks Amphitheatre shall NOT have any liability or obligation to winner and/or winner's guest of any kind. Tickets may be non-transferable and resale of tickets may be prohibited. **Prize will only be awarded to winner with a verified street address within the 48 Contiguous United States or District of Columbia.**

COVID-19 WARNING:

Winner and winner's guest understand and agree an inherent risk to exposure to COVID-19/ Coronavirus epidemic/ pandemic exists in any place where people gather. COVID-19/Coronavirus is an extremely contagious disease that can lead to severe illness and death. Winner and winner's guest assume all risks, hazards, and dangers arising from or relating in any way to the risk of contracting a communicable disease or illness—including, without limitation, exposure to COVID-19/Coronavirus or any other bacteria, virus or other pathogen capable of causing a communicable disease or illness, whether that exposure occurs before, during or after the Concert, and regardless of how caused or contracted—and winner and winner's guest waive any and all claims and potential claims against Can'd Aid, Tyler Childers, Sponsors, City and County of Denver and/or Red Rocks Amphitheatre, and each of their respective parent companies, partners, divisions, subsidiaries, officers, directors, members, managers, agents, affiliates, and employees — relating to such risks, hazards and dangers. Winner and winner's guest also agree to fully comply with all applicable government mandates and venue policies so as to protect against the spread of COVID-19/Coronavirus. Such mandates/policies may include mask-wearing, social distancing, completion of a health questionnaire as well as conditioning venue admission attendance upon a negative COVID-19/Coronavirus test and/or provision of adequate and satisfactory proof of being fully vaccinated against COVID-19/Coronavirus (including booster). If winner or winner's guest refuse to comply with such mandates/policies or if winner or winner's guest cannot satisfy applicable conditions, he/she/they will be denied admission to venue, with Organization, Sponsors, City and County of Denver and Red Rocks Amphitheatre not having any liability under any legal theory to winner and/or winner's guest (as applicable).

6. WINNER DETERMINATION/ODDS:

The odds of winning the prize or prizes depend on the total number of eligible Sweepstakes Tickets issued.

Entry in the Sweepstakes constitutes an entrant's full and unconditional agreement to abide by and accept the terms and conditions of these Official Rules. No prize substitution except at Organization's sole discretion due to unavailability for any reason and only then for prize/prize element of comparable value. Prize is not redeemable/exchangeable for cash, except with regard to gift card element of prize as may be required by applicable law. Prize is not transferable except with Organization's prior consent which may be granted or withheld in its sole discretion without liability of any kind. All federal, state and local taxes on the prize are winner's sole responsibility. By accepting the prize, winner waives the right to assert as a cost of winning the prize, any and all costs of redemption or travel to redeem the prize and any and all liability that might arise from redeeming or seeking to redeem the prize. Winner also accepts sole responsibility for any miscellaneous costs relating to acceptance of the prize.



Taxes on the prize are winner's sole responsibility. Winner will be issued W-9 IRS Tax Form with the Affidavit of Eligibility, Liability and Publicity Release and a subsequent 1099 IRS Form. Upon receipt of the prize, winner shall be required to comply with any and all applicable federal, state and local law, rules and regulations.

Organization makes no warranties, and hereby disclaims any and all warranties, express or implied, concerning the prize furnished in connection with this Sweepstakes. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, THE PRIZE IS PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND ORGANIZATION AND ITS DESIGNEES HEREBY DISCLAIM ALL SUCH WARRANTIES, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND/OR NON-INFRINGEMENT. A PARTICIPANT'S SOLE AND EXCLUSIVE REMEDY FOR A BREACH BY THE ORGANIZATION SHALL BE LIMITED TO THE RETURN OF THE DONATION FOR HIS OR HER SWEEPSTAKES TICKET(S). IN NO EVENT SHALL THE ORGANIZATION OR THEIR DIRECTORS, OFFICERS, EMPLOYEES, VOLUNTEERS, AGENTS OR REPRESENTATIVES BE LIABLE TO ANY PARTY FOR ANY LOSS OR INJURIES TO EARNINGS, PROFITS OR GOODWILL, OR FOR ANY INCIDENTAL, SPECIAL, PUNITIVE OR CONSEQUENTIAL DAMAGES OF ANY PERSON OR ENTITY WHETHER ARISING IN CONTRACT, TORT OR OTHERWISE, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

The prize or prizes will be transferred to the prize winner(s) **"AS IS, WHERE IS, AND WITH ALL FAULTS". THE ORGANIZATION DOES NOT PROVIDE ANY GUARANTEE OR WARRANTY, EXPRESSED OR IMPLIED, IN CONNECTION WITH THE PRIZE OR PRIZES AND ACCEPTS NO LIABILITY OR RESPONSIBILITY REGARDING THE CONSTRUCTION OR CONDITION OF THE PRIZE OR PRIZES. THE ORGANIZATION DOES NOT WARRANT THAT THE PRIZE OR PRIZES ARE OF MERCHANTABLE QUALITY OR THAT THEY CAN BE USED FOR ANY PARTICULAR PURPOSE. 7. SELECTION OF WINNER:

The Sweepstakes will be held by 5:00pm MST on September 8, 2023 from all eligible Sweepstakes Tickets. Winner need not be present to win.

Winner will be notified according to the contact information provided to the Organization at the time of the entry. The prize is forfeited if the prize winner cannot be located by 5:00pm MST on September 10, 2023 after attempting to make contact through the information provided at the time of entry. The Organization will make all reasonable efforts to notify the potential prize winner. If the prize winner cannot be located by 5:00 pm MST on September 10, 2023, a new winner will be drawn from the remaining eligible Sweepstakes Tickets.

In order to collect his/her/their prize, a prize winner must sign and deliver to the Organization: (a) a sworn affidavit of eligibility in accordance with these Rules and Applicable Laws, including, without limitation, that he or she is at least 18 years old; (b) such written information as is required by any applicable tax laws, including, without limitation, his or her Social Security Number; (c) proof of identity



in forms satisfactory to the Organization showing that the person claiming the prize is the same person who is named on the winning ticket and (d) a signed Liability and Publicity Release.

7. PUBLICITY:

Organization's computer is the official clock for all purposes of the Sweepstakes. If the Sweepstakes (or any part thereof) is not capable of running as originally planned for any reason beyond the control of Organization (e.g., natural disaster, pandemic/epidemic, unauthorized intervention, fraud, civil commotion), Organization reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes and conduct the Sweepstakes and select the winner from among all eligible entries received for the random Sweepstakes prior to the action taken by Organization or otherwise in a manner which is fair, equitable and in accordance with these Official Rules, as



determined by Organization in its sole discretion. Notice of such action by Organization will be posted on the Can'd Aid Instagram page.

10. TAMPERING:

If a Sweepstakes entry is lost, destroyed or corrupted, the entrant's sole remedy shall be receipt of a replacement entry, time permitting and if otherwise feasible; if not feasible (as determined by Organization in its sole discretion), Organization shall not have any liability of any kind relative to same. Only the type and quantity of prize described in these Official Rules (i.e., one [1] Prize) is available to be won in the Sweepstakes. Organization's failure to enforce any provision of these Official Rules in a given instance shall not represent the waiver of such provision. Should a court of competent jurisdiction deem a given provision of these Official Rules to be invalid, illegal or unenforceable, such provision will be replaced with a substitute provision which is valid/legal/enforceable and most closely approximates the original intent of Sponsor. The invalidity, illegality or unenforceability of any provision of these Official Rules shall not affect the validity, legality or enforceability of any other provision of these Official Rules.

12. DISPUTES:

This Sweepstakes is governed by the laws of the State of Colorado, without respect to conflict of law/choice of law doctrines of Colorado (or of any other jurisdiction which would lead to the application of the law of any jurisdiction other than Illinois). To the fullest extent permitted by law, as a condition of participating in the Sweepstakes, entrant agrees (a) that any and all disputes regarding the Sweepstakes which cannot be resolved between the parties shall be resolved individually, without resort to any form of class action, exclusively before a federal or state court located in Boulder County, Colorado; (b) to the personal jurisdiction of such courts and to waive any right of inconvenient forum, change of venue or any like right; (c) that any claims, judgments and awards shall be limited to actual out-of-pocket costs incurred in entering the Sweepstakes (if any), but in no event attorney's fees, with all other forms of remedy – including but not limited to punitive, incidental, or consequential damages and injunctive relief – being expressly waived.
